#### SOME THRILLING TESTIMONIES OF SACRIFICIAL GIVING

ur consultant, John L. Hessel, reports some thrilling illustrations of sacrificial giving from other capital stewardship campaigns.

A Florida school teacher had plans to retire and to buy a new car. After being challenged to pray about her commitment, she decided to forego both retirement and a new car and commit \$40,000 for the church's building expansion.

In North Carolina, an elderly couple had saved money to attend the World's Fair. After praying about their commitment, the couple canceled their plans and committed to give what they had saved to the new worship center. They said, "What we invest in God's work will pay dividends for God's kingdom long after we die."

A couple from Oklahoma was saving to buy a new home. When their church decided to build a new educational building, the couple gave what they had saved to the church and postponed their move to a larger home for two more years.

After a successful career as an executive secretary, a Missouri woman was planning to retire. She decided to postpone her retirement for three years, so she could give a more worthy offering to her Church from those extra earnings.

In Texas, a young couple, wanting to have a larger part in helping their church build a new worship center, decided to give their boat, motor, and trailer to the church. In addition, they made a three-year capital stewardship commitment.

While explaining his family's commitment, an Illinois deacon said, "I've learned that my commitment is not just a financial matter between me and the church, but a spiritual matter between me and the Lord." He went on to say, "I had saved to buy a new truck this year. Last night, the Lord asked me to drive my old truck for three more years, as part of my sacrifice, and I said yes. Though you can't see it, I am laying a truck on the altar tonight for our new building."

Stories of faith such as these abound in churches all across America, as families have experienced the inner joy of sacrificial giving for the kingdom of God. It is no wonder that, with such expressions of commitment, those churches achieved financial and spiritual success in capital stewardship campaigns.

"God did a tremendous work in the hearts of our people. Our capital stewardship campaign did more for our church spiritually than even the raising of the money," said a Missouri church pastor after witnessing his church attain their hallelujah goal.

The word sacrifice means "to make something sacred." Through efforts such as these, people have made savings, stocks, boats, even a pony sacred by committing them to the Lord's work through their church. As we pray about our commitments in *Vision for Tomorrow*, may our sacrificial gifts be inspired by the sacrifice of Jesus on the cross, God's "unspeakable gift." (2 Cor. 9:15).

### I WANT TO GIVE MORE . . . BUT

ost families ask, "How can I give more to help my church achieve its goal? Perhaps your family may be able to give more generously, by using ways of giving other than by cash. Consider the following suggestions:

- 1. Give an asset (real property, stocks, bonds, other investments) directly to the church for resale. If you are unable to give an asset in its entirety, perhaps you might sell it to the church at a bargain price. (Giving appreciated stock can help avoid capital gains taxes as well as being a contribution.)
- 2. Set up a charitable remainder or revocable living trust, a gift or deferred gift annuity, making the church the ultimate beneficiary of the trust.
- 3. Give through your corporation rather than from personal assets and income.
- 4. Make the church the beneficiary of an insurance policy that is no longer needed for the protection of your family.


- 5. Provide for the church through your will.
- 6. If you give by cash, consider giving the tax saving which your gift allows as well.

# When do we begin giving our *Vision for Tomorrow* commitments?

Though some families have already started giving their commitments, most families will begin giving November 4th, after Celebration Sunday.

#### How may I give my commitment?

Place your commitment payment in an offering envelope, plainly marked *Vision 4 Tomorrow* on the Building Fund line. Here is an example:



# What happens if I need to change my commitment?

Most families will be able to give what they commit. Some families may decide to give more than they committed. A few families may have to revise or cancel their commitments when faced with unexpected adversity. If you need to change your commitment, you may call the church office, or you may simply adjust your giving.

#### Can a family give without making a commitment?

Yes. However, we encourage you to make a commitment. To do so will provide you with a goal that you have set for your giving; it will strengthen your good intentions to give; and it will increase your joy in giving. In addition, your commitment will unite with those of other church families to provide a collective witness of your support of the church's ministry and dreams for growth, and will give needed financial information for planning the building process.
